NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A CONDITIONAL USE PERMIT FOR A CULTURAL EDUCATION SCHOOL "HARMONIA" AT 2200 BRIDGEWAY (THE PLANT) CUP 12-134

PROJECT DESCRIPTION

The applicant, McCoy Architecture, Inc., requests Planning Commission approval of a Conditional Use Permit for a cultural education school at 2200 Bridgeway (APN 063-110-01). The cultural education school would operate Tuesday-Sunday from approximately 8am-7pm and offer classes such as yoga, trigger point therapy, healing arts dance, meditation, nutrition, aroma therapy, acupuncture/pressure, life coaching and feng shui.
