PROJECT DESCRIPTION

The applicant, One Source Security & Sound, Inc., on behalf of the property owner, Wells Fargo Bank, requests Planning Commission and Historic Landmarks Board approval of a Design Review Permit to replace one existing Automated Teller Machine (ATM) with a new ATM in the same location on the front elevation of the Wells Fargo Bank building located at 715 Bridgeway (APN 065-071-25).

The project requires a joint meeting with the Planning Commission and Historic Landmarks Board as the structure is in the Downtown Historic Overlay District.
