

**You are invited to attend a Planning Commission and  
Historic Landmarks Board public hearing on the following project.**

- PROJECT DESCRIPTION** The applicant, Eduard Llorca, on behalf of property owners, Chris Henry, William Henry, and Wynona Henry, requests a joint Planning Commission and Historic Landmarks Board approval of modifications to a previously-approved Design Review Permit for façade modifications, including modifications to the approved mechanical equipment and screens, and the installation of new planters. All of the improvements are proposed for the building at the Barrel House Restaurant. All of the improvements are proposed for the building at 660 Bridgeway (APN 065-133-25), which is located in the Downtown Historic Overlay Zoning District.
