**PROJECT:** John McCoy Architects, on behalf of the property owner Jeanine Campbell, is requesting approval of a Design Review Permit to allow for an addition to an existing condominium which includes the new construction of a two-car garage within the footprint of an existing parking deck, a breakfast room addition to the ground floor, and the conversion of the basement and crawlspace to habitable floor area, including the construction of a new exterior deck located at 101 Lincoln Drive (APN 064-322-24).
