




**CITY OF SAUSALITO

- PROJECT DESCRIPTION** The applicant, Amy Clawson, on behalf of the property owner, Anthony and Roxanne Marterie, is requesting Zoning Administrator approval of a Minor Use Permit (MUP 15-237) for a private temporary outdoor concert series located at 20 Liberty Ship Way (APN 063-090-06). The private concert series will occur from 4pm to 6:30pm once a month in October 2015 and from June through October 2016.
