



**CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION AND HISTORIC LANDMARKS BOARD PUBLIC HEARING FOR A DESIGN REVIEW PERMIT, ENCROACHMENT AGREEMENT, AND ACCESSORY DWELLING UNIT PERMIT | 168 HARRISON AVENUE / DR-EA-ADU 15-191**

You are invited to attend a Planning Commission and Historic Landmarks Board public hearing on the following project:

**PROJECT DESCRIPTION** Michael Rex Architects, on behalf of property owners Asriel and Carmela Levin, is requesting approval of the following for 168 Harrison Avenue ("Tanglewood"), a property listed on the Local Historic Register: a Design Review Permit for remodel/addition of the existing 3,015 square foot residence (two-level with basement level) to a proposed 5,095 square foot residence, demolition of a 368 square foot one-car garage for construction of a new 1,075 square foot three-car garage, construction of a new pool, spas, patios, 120 square foot greenhouse, and landscaping; an Encroachment Agreement for replacement/widening of the driveway along Harrison Avenue and planting area and portions of existing fencing and steps adjacent to the Harrison Avenue and Bulkley Avenue right-of-ways; and an Accessory Dwelling Unit Permit to replace an existing 180 square foot accessory building with a new 536 square foot accessory dwelling unit located lower on the site, northeast of the residence (APN 065-091-10).


**MEETING DAY/TIME** December 9, 2015 at 6:30 PM
