### AGENDA TITLE:

Approve request from Bill Ring to be re-appointed for a four-year term on the Board of the Marin Sonoma Mosquito and Vector Control District

### RECOMMENDED ACTION:

Re-appoint Bill Ring to a four-year term as the City's representative on the Marin/Sonoma Mosquito and Vector Control District Board

### SUMMARY

On January 29, 2008, Bill Ring was appointed to the vacant seat for the Sausalito representative on the Marin Sonoma Mosquito and Vector Control District. Mr. Ring was appointed to a two year term.

Prior to this appointment, the seat had remained vacant for some time, having been vacated by the retirement of a long-term Councilmember. It was especially hard to fill this seat with a Councilmember, mostly because the Board meets in Cotati during evening hours. Board members may be either Councilmembers or residents.

Now that Mr. Ring's first term is expiring, the second and future terms, may be for a period of two or four years. After contacting Mr. Ring, he is willing to serve for four years. As was noted at the time of his original appointment, Mr. Ring comes well qualified with academic degrees in science and engineering and an MBA from UC Berkeley. It is acknowledged, by staff and Council, that Mr. Ring has demonstrated a commitment to the best interests of this community through his service on the Sausalito Waste and Recycling Commission and his willingness to serve through his first term on the Vector Control Board.

### ISSUES

Representation on this Board is extremely hard to find. At this point in time, Mr. Ring has been the only person to step forward and request consideration.


**STAFF RECOMMENDATION**


