**2. Public Comment On Items Not On Agenda - None**

**3. Approval Of Minutes – September 13, September 20, September 27, and October 11**  
*The Committee amended the September 13 minutes and Stan Bair moved and Steve Flahive seconded a motion to elect approve the minutes. The motion passed unanimously.*

**4. Discussion: HEC Next Steps**

- a. HEC Goal Recap – *Chair Pfeifer indicated that the HEC goal as discussed by the HEC at the October 18 meeting was amended by the City Council at the October 19 Council meeting to read:  
“To accommodate the 372 RHNA through 2014 in a manner that has positive and minimal impact on Sausalito.”  
The Committee discussed the HEC goal.*
- b. Work Program Update – *Associate Planner Schinsing presented a revised HEC work program which incorporates the subcommittee work. HEC directed staff to establish target dates for the vacant land, underdeveloped land and ADU-Multifamily data and to present that information at the next HEC meeting.*
- c. First Community Workshop – *The Committee directed Staff to add a discussion of the first community workshop to the next HEC agenda.*

- b. Accessory Dwelling Units in Single Family Districts (Schinsing, Visher) – *Associate Planner Schinsing distributed copies of a report presented to the Committee at the October 11 HEC meeting. Committee Member Stoddard requested that the pie charts be changed to bar graphs for clarity. Committee Member Stoddard and Linda Pfeifer volunteered to look at the comment responses in the report and look for common themes. The Committee directed Staff to explore the number of ADUs counted towards the RHNA in the 1995 Housing Element and how they fit into the current RHNA.*
