**PROJECT DESCRIPTION** The applicant and property owner, the City of Sausalito, is requesting Planning Commission approval of a Design Review Permit for the demolition of the existing downtown restrooms and construction of new downtown restrooms along the 700 Block of Bridgeway between Anchor and Bay Streets (APN 065-073-02). The applicant is also requesting a tree removal permit to remove one protected tree in association with the project.
