## 5. Marin Economic Forum Economic Development Study – Progress Report

*Robert Eyler of the Marin Economic Forum reviewed his written report and noted that he had set up times at City Hall to meet with business owners and residents. He has also prepared a draft survey questionnaire that he would provide to the BAC for review. Adam Krivatsy noted that it would be helpful for the study to review the positive fiscal impacts of new workers occupying existing vacant commercial spaces as well as the overnight stays by business visitors to Sausalito. CD Director Jeremy Graves distributed a memorandum from Michael Rex regarding strengths, weaknesses, and opportunities in operating a business in Sausalito.*

## 6. Commercial Property Data Base/Short Term Business Needs Study – Continued Discussion of Office Uses

*Eckart Noack indicated he would coordinate with Joe Lemon on clarifying the industrial uses on Joe's property. Eckart also said the Class A office space in Sausalito is comparable to the Class A office space in Mill Valley and Corte Madera. The vacancy rates are more driven by the economy than the particulars of Sausalito's office space opportunities. Peter Van Meter said the data base should be presented to Rob Eyler for use in the Economic Development Study and to the City Council. Eckart indicated that the "off-beat" tradition in Sausalito can be used to market office space to creative and design businesses. By consensus, the Commercial Property Data Base/Short Term Business Needs Study was accepted with Eckart's forthcoming changes on the Lemon property. Peter Van Meter said the next step is to develop an action plan.*
