NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW PERMIT, VARIANCE, ENCROACHMENT AGREEMENT, AND TREE REMOVAL PERMIT TO ALLOW FOR IMPROVEMENTS AT 22 ATWOOD DR/VA/EA/TRP 13-196

You are invited to attend a Planning Commission public hearing on the following project.

PROJECT DESCRIPTION

The applicant, Martin Bernstein, on behalf of the property owners, Johannes and Beverly Figel, requests Planning Commission approval of the following land use entitlements to an existing legal nonconforming single family dwelling located at 22 Atwood Avenue (APN 065-203-02):

Design Review Permit to allow modifications and additions to an existing dwelling including construction of the following: a stairway from Atwood Avenue to the first floor of the dwelling, a fourstory elevator shaft on the west elevation, a master bedroom expansion on the first floor, a dining room on the second floor along with a wrap around covered deck, a basement workshop, retaining walls, paths, and landscaping throughout. The proposal also includes the demolition of an existing parking deck on Atwood Avenue and new construction within the North Street public right-of-way including a two-car garage, garage roof deck, walkways, retaining walls, stairs, and landscaping.

Variance from building coverage, floor area, impervious surfaces, and side and rear yard setback standards to accommodate the project.

Tree Removal Permit to remove all on-site trees, in addition to the removal of a Coast Live Oak located in the North Street right-of-way fronting 26 Atwood Avenue (APN 065-203-03).

Recommendation for City Council approval of an Encroachment Agreement to allow for proposed improvements to be located within the Atwood Avenue and North Street public right-of-ways.
