



CITY OF SAUSALITO NOTICE OF PLANNING COMMISSION PUBLIC HEARING FOR A DESIGN REVIEW PERMIT, TREE REMOVAL PERMIT, AND A RECOMMENDATION OF CITY COUNCIL APPROVAL OF AN ENCROACHMENT AGREEMENT AT 220 CURREY LANE

You are invited to attend a Planning Commission public hearing on the following project.

PROJECT DESCRIPTION

Jazz Builders, Inc., on behalf of the Robert and Josephine Moretto 2011 Living Trust, requests approval of: a Design Review Permit to construct a 3,907 square-foot, two-level, single-family residence with attached two-car garage and associated improvements at 220 Currey Lane (APN 064-232-12), a Tree Removal Permit for the removal of seven trees, and a recommendation of City Council approval of an Encroachment Agreement for a driveway, walkways, retaining walls, on-grade stairs, and landscaping improvements in the public right-of-way. The project entails demolition of the existing approximately 1,032 square-foot, two-level, residential structure on the property. The project is subject to Heightened Design Review (DR-EA-TRP 15-162).
